

eStatement Contest

Opt-out of receiving paper statements and switch to eStatements from Nelson & District Credit Union before May 31, 2010, and you'll be automatically entered to win a Home Energy Assessment (in the form of a \$300 gift certificate from City Green Solutions, <http://www.citygreen.ca>).

Contest Rules

No purchase necessary. Members are automatically entered in the contest when they complete the paper statement opt-out process through online banking or in-branch. Members who have already opted-out of receiving paper statements have already been automatically entered in the contest.

Contest commences January 25, 2010 and runs to May 31, 2010. Limit of one entry per person. Members must complete the paper statement opt-out process on or before the contest closing date to be entered in the draw.

One (1) winner will receive a \$300 gift certificate plus GST & mileage from City Green Solutions, <http://www.citygreen.ca>, for a home energy assessment.

The prize must be redeemed by September 30, 2010.

Contest is open to all Nelson & District Credit Union members who are individuals and residents of BC, Canada; excluding employees and members of the immediate families of Nelson & District Credit Union.

Due to the nature of the home energy assessment only certain buildings are eligible.

Eligible buildings include:

- a single family home, duplex, or other row townhouse or
- a mobile home on a permanent foundation

Ineligible buildings include:

- Single family homes with a suite or other area that does not share airflow with the rest of the home
- Condos and apartment
- Townhomes that have stacked units

Nelson & District Credit Union representatives will randomly draw 1 name from all eligible entries. The selected potential winning entry will be verified. A Nelson & District Credit Union representative will contact the winner by telephone, and before being declared a winner, will have to correctly answer within a limited time period a skill-testing question. If for some reason it is not possible to contact the potential winner after 10 business days, or they are ineligible, then the next closest potential winner will be provided.

Before being declared a winner, selected entrants will be required to sign the contest sponsor's declaration and release form:

- Confirming compliance with contest rules and acceptance of prizes as offered
