Official Contest Rules, Terms & Conditions

CONTEST PERIOD

The "Give Your Money Purpose" Contest begins at 12:00 am PST on November 9, 2018 and ends at 11:59 pm PST on or before December 22, 2018. The Contest is organized and sponsored by Nelson & District Credit Union (NDCU).

ELIGIBILITY

The Contest is open to all legal residents of British Columbia who are of the age of majority at the time of entry into the Contest. Employees and representatives of Nelson & District Credit Union or its subsidiaries and affiliates, are not eligible to win, nor is any person related or not, living in the same home as the employee or representative.

HOW TO ENTER

To enter, entrants must invest a minimum of \$10,000 in a Nelson & District Credit Union two-year (2.75%) or three-year (3.00%) special term deposit during the contest period. One entry into the contest per member. Exception: members investing in both deposits with a minimum of \$10,000 in each will receive two entries. A Nelson & District Credit Union membership is required. If investors do not wish to be entered into the Contest, they must indicate their preference to opt out at the time of their investment.

PRIZE

- There is ONE (1) grand prize available to be won.
- The selected winner will receive one \$1000 non-redeemable one-year NDCU term deposit.* Interest will be paid at maturity/redemption. * Standard NDCU one-year non-redeemable term deposit rates and conditions apply.

DRAW DATE

The prize draw will take place on or before December 31, 2019 at 10:00 am PST. The Winner will be notified by telephone and will be required to prove identity. Nelson & District Credit Union will make reasonable attempt to contact potential winners by telephone within 10 business days following the date of the draw. If a potential winner cannot be contacted within the time frame indicated above, the prize will be awarded to an alternate entrant who will be selected from the remaining eligible entries.

PRIZE AWARDING

Before being declared the winner, the selected entrant must first correctly answer a time-limited mathematical, skill-testing question. In addition, the selected entrant must sign a waiver of Liability, Rule Compliance, and Publicity Release, agreeing to the use of their name, photo, voice and/or statements without compensation other than the prize offered. Failure to complete and sign the required release form will result in the selected entrant being disqualified and another entry will be drawn.
