- A complete and thorough application, accompanied by the appropriate supporting documents, enables our review committee to make timely and well-informed decisions about your application.
- Due to the number of donation requests NDCU receives on an annual basis, we cannot always approve every request to its full amount. Each request will be given fair consideration based upon the evaluation criteria provided and the state of funds available in the CIP.
- Receiving a donation in one year does not mean NDCU can/will make a similar commitment in following years. On-going commitment will be reviewed with consideration to the future impact, success, viability and sustainability of the request.
- All requests will be reviewed by our Community Impact Program Team and/or our Board of Directors. Allow approximately two months for a decision to be made, while large donation requests and complex applications may take longer.
