First, NDCU is having a strong year financially. Our financial health ensures we can

continue to offer loan and deposit rates that are as good, and often better, than

market rates. Our mortgage rates are currently below our competitors in our market. Our rates and the efforts of our lending teams have enabled NDCU to grow loans despite the slow real estate market in 2024.

Financial health also enables NDCU to continue to support our communities through our Community Investment Program. This year, we are on track to share approximately \$200,000 with local organizations and initiatives. We are
